Suzaku Funding FY08-FY12

- In 2009, substantial in-guide budget reduction from 2008 level
 - Planned reduction of hardware team funding
 - Substantial reduction of funding for GO grants (US participation was expected to be reduced)
 - FY09-12 budget, formulated in 2006, was predicated on reduced US participation in Suzaku (lesser share of observing time)
- 2008 Senior review proposal sought restoration of GO funding to \$1.7M annual level for FY09-12
- Senior review recommended funding at in-guide through FY 12 (which included modest GO funds growth in FY11 and FY12)
- Guideline from NASA gave full funding in FY09 and FY10, but reduced FY11 funding and eliminated FY12 funding
 - Only \$500k nominally available for GO grants in FY9-11
 - Despite its high ranking in the senior review, Suzaku will have to request an "overguide" budget just to operate in 2012!

FY09 Suzaku budget

- Total budget is \$2.35M
- \$500k allocated for GO grant support (spent on AO3 proposals)
- Economy within GOF allowed savings of \$250k, increasing the available AO4 grant funding by 50 percent
- FY10 budget is essentially identical
 - Project team will continue to be frugal, but cannot promise how much it can save (already at "bare bones" staffing)
